

POWERTRAIN

Engine | Cylinder heads, block, and all internal parts, rocker covers, oil pan, valve train and front cover, timing chain and tensioner, oil pump, fuel pump, fuel injectors, intake/exhaust manifolds, supercharger and turbocharger, flywheel, and seals and gaskets.
