## HOW PAYMENTSHIELD WORKS

The benefit available is dependent on your payment tier. Below is an example assuming a maximum total benefit of \$2,500:

If Payment Is  
**\$399/MO** May receive a monthly reimbursement for entire payment for up to six (6) months.

If Payment Is  
**\$499/MO** May receive a monthly reimbursement for entire payment for up to five (5) months.

If Payment Is  
**\$999/MO** May receive a \$999 reimbursement for two (2) months, then receive \$502 toward the third month's payment.

## COVERAGE DETAILS

In the event you are terminated or furloughed from your current employment, we agree to reimburse you the eligible payment protection reimbursement amount within 30 days of proof of payment of the monthly vehicle payment amount, subject to the terms and conditions of your payment protection agreement.
